NOTE

- 1. No admission shall be made to a course / subject for which the College has not been granted affiliation and no admission shall be made to a course / subject for which syllabus and regulation are not approved and notified for implementation.
- 2. It shall be the sole responsibility of the Principal or Head of the Institution to see that the admissions are made as per the regulations prescribed for the course and other guidelines, issued by the University. Admission made in contravention of regulations and guidelines shall automatically become invalid.
- 3. All students who have passed Pre-University course outside Karnataka State shall apply for Eligibility Certificate in the prescribed proforma along with the Marks Card, Cumulative record and all other required documents. No admission of such students shall be made by the Institutions without the production of Eligibility Certificate issued by the Competent Authority.

Foreign students, in particular, may be admitted only on production of the following documents.

(a). Eligibility Certificate issued by Tumkur University.

(b). Student Visa and

- (c). AIDS free certificate issued by the Competent Authority
- 4. No student shall be eligible for admission to the Under Graduate degree course unless he / she has successfully completed two years of Pre-University course through an examination conducted by a Pre-University Board or any other examination recognized as equivalent.
- 5. No admission shall be made in excess of the intake sanctioned by the University / State Government. Such admissions shall be invalid as per section 59(18) of K.S.U. Act 2000.
- 6. All the provisions of regulations in force for the course including attendance requirements and scheme of examination shall be brought to the notice of the students, every year, at the time of admission and a compliance report to this effect shall be sent along with the statement of admission.
- 7. No transfer admission shall be made without the prior permission of the University.
- 8. The concerned College shall make all admissions within the last date fixed for the courses in the respective year. No admission shall be made after the last date fixed for admission by the University and any admission made to a course after the last date shall automatically become invalid.

- 9. The Principal / Head of the Institution shall submit the statement of admission along with fee receipt of each student (copies of fee receipts and extracts should be sent to the Finance Officer, Tumkur University, Tumkur) in triplicate, on or before 10.08.2017. No original documents such as Marks Cards, Eligibility Certificates etc., should be submitted to the University. The college Authorities will be informed to produce all the necessary documents to the Academic Section on a particular date. The Principal / Head of the Institution while submitting the statement of admission shall certify that all the admissions made are in accordance with the regulation issued by the University pertaining to admissions of the students. He / She shall also send the compliance report as required under Para 6 of the Notification.
- 10. The statement of admissions made in respect of the students who have studied outside Karnataka State should be submitted separately along with necessary documents including Eligibility Certificates. The serial numbers of these students should be given continuously after the names of students who have studied in Karnataka.
- 11. The Calendar of events shall be notified for the information of all staff and students of the Institution.
- 12. In the event of any of the above date being holiday the activity shall commence on the next working day.
- 13. Late submission of admission statement will attract penalty as may be prescribed by the University.
- 14. The College shall submit admission data Online as per the guidelines to be issued in this regard.
