NOTE

- No admission shall be made to a course / subject for which the College has not been granted affiliation and no admission shall be made to a course / subject for which syllabus and regulation are not approved and notified for implementation.
- It shall be the sole responsibility of the Principal or Head of the Institution to see that the admissions are made as per the regulations prescribed for the course and other guidelines issued by the University. Admissions made in contravention of regulations and guidelines shall automatically become invalid.
- 3. In respect of the students of the other states who are seeking admissions in the constituent / affiliated colleges of this University, the Principals of the colleges are hereby strictly informed to ensure that the student has passed 10+2 or equivalent examination or Undergraduate Degree from Boards recognized by the COBSE / AIU respectively and admissions should be made only after obtaining Eligibility Certificate by paying prescribed fees to the University. Admissions made without obtaining Eligibility Certificate will not be approved.

Foreign students, in particular, may be admitted only on production of the following documents.

- (a). Eligibility certificate.
- (b). Student Visa and
- (c). AIDS free certificate issued by the Competent Authority
- (a) All students who have completed Degree courses from other University shall produce Migration Certificate at the time of admission.
 - (b) No student shall be eligible for admission to the B.P.Ed. degree course unless he / she satisfies the eligibility criteria as specified in the Regulations.
- No admission shall be made in excess of the intake sanctioned by the University / State Government. Such admissions shall be invalid as per section 59(18) of K.S.U. Act 2000.
- 6. All the provisions of regulations in force for the course including attendance requirements and scheme of examination shall be brought to the notice of the students, every year at the time of admission and a compliance report to this effect shall be sent along with the statement of admission.

- 7. No transfer admission shall be made without the prior permission of the University.
- 8. The College shall make all admissions within the last date fixed for the course in the respective year. No admission shall be made after the last date fixed for admission by the University and any admission made to the course after the last date shall automatically become invalid.
- 9. The Principal / Head of the Institution shall submit the statement of admission along with fee receipt of each student (copies of fee receipts and extract should be sent to the Finance Officer, Tumkur University, Tumkur) in triplicate on or before 16.09.2017. No documents such as Marks Cards, Eligibility Certificate, etc., should be submitted to the University. The college authorities will be informed to produce all the necessary documents to the Academic Section on a particular date. The Principal or Head of the Institution while submitting the statement of admission shall certify that all admissions made are in accordance with the regulations issued by the University. He / She shall also send the compliance report as required under Para 6 of the Notification.
- 10. The Calendar shall be notified for the information of all the staff and students of the Institution.
